# Impact With Intention

**Our Mission:** Change the way kids learn about careers and prepare for their futures through equitable access to career readiness information and experiences.

## Who We Serve

Middle and high school-aged learners and the education-to-career ecosystem in all U.S. communities, with an emphasis on historically underserved communities who lack access to career-connected learning (CCL), including rural youth, systems-involved youth, youth of color, Indigenous youth, immigrant youth, English language learners and youth with disabilities

## What We Fund

### Explore

Career exploration and readiness programming focusing on self-awareness, life readiness, skill-building, education planning, career exposure and identifying unique strengths

### Experiment

Experiential learning including hands-on real world experiences such as internships, apprenticeships, project-based learning, career mentoring, entrepreneurship and profession-based learning

### Navigate

Tools and research promoting informed post-high school decision making through career counseling or mentoring, post-secondary educational experiences and credentials, including early college, non-degree paths, and launchpad jobs

## What We Hope to Achieve

- Meaningful direct impacts on kids that result in **increases in knowledge, gains in confidence, and changes in behavior** as related to career readiness and future planning.
- Greater opportunity for all students to be career ready through **raised awareness, influenced policy changes and increased coordination or integration of CCL in education systems.**

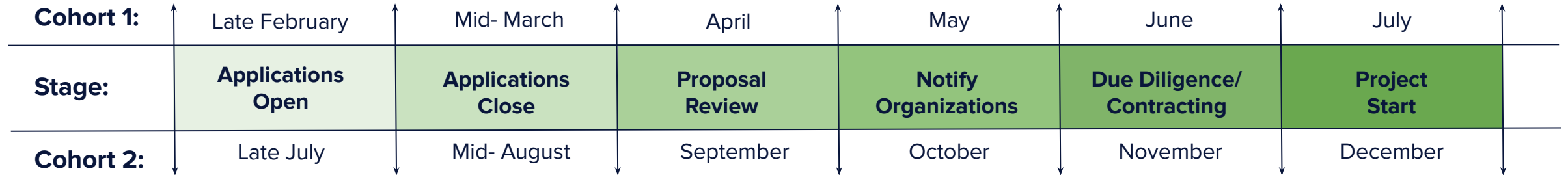
# Eligibility Criteria & Funding Pools

<p><b>In order to be eligible for funding, prospective partners must:</b></p> <ul style="list-style-type: none"> <li>✓ Align with ASA’s vision for impact with intention and our approach</li> <li>✓ Have valid 501(c)(3) nonprofit certification, fiscal sponsorship, or infrastructure for managing philanthropic grants</li> <li>✓ Propose an initiative that benefits middle and/or high school youth</li> <li>✓ Consider removing barriers for all youth to participate in career connected learning (CCL), with emphasis on historically underserved or underrepresented populations</li> </ul>	<p><b>We do not fund:</b></p> <ul style="list-style-type: none"> <li>× Programs that only address academic outcomes, with limited ties to CCL</li> <li>× Individual pursuits such as tuition/scholarships or travel costs</li> <li>× Direct lobbying efforts</li> <li>× Religious activities</li> <li>× Fundraising events or galas</li> <li>× Capital campaigns for building renovations or acquisitions</li> <li>× Costs of sustaining an existing program, with limited plans to expand or scale</li> <li>× Programs for adult learners (18+) only</li> </ul>

**We offer 3 types of funding:**

# Timeline & How to Apply



## Instructions:

1. Please submit an [eligibility form](#) through our website.
2. ASA's CSR team will review your submission and respond within 2 weeks. Our team may reach out for additional information to assess alignment. Eligible organizations will be invited to submit a full application for consideration.
3. Funding decisions will be made according to the timeline provided above.

# Review Criteria

<b>Proposal Alignment to ASA's Mission</b>	Organization provides or promotes career connected learning (CCL) through exploration, experimentation, or navigation ( <i>see prior slides</i> )
<b>Innovation</b>	The organization will implement new practices (digitally or in-person) or demonstrates significant potential for advancing the field. Organization can clearly articulate its strengths or capacity for advancing the field, as well as what sets it apart in the regions they operate within.
<b>Evidence of Community-centric Approach</b>	The organization demonstrates a strong commitment to removing barriers for participation in CCL, which is clearly reflected in its mission, vision, and values. This commitment is further evident through well-defined programs or plans, as well as representation of the lived experiences of those served by the organization at the executive and board levels.
<b>Thought Leadership</b>	Ability to impact or engage key audiences <ul style="list-style-type: none"> <li>● Students</li> <li>● Educators</li> <li>● Employers</li> <li>● Parents/guardians</li> <li>● Researchers</li> <li>● Community Partners</li> <li>● Program/Product Partners</li> <li>● Policy Makers</li> </ul>
<b>Impact: Potential for Scale</b>	Implementation plan can easily be expanded beyond initial audience and/or replicated in other contexts. Funding would be used to expand on existing programming by adding a new component, population served OR widening program scope by location or content area.
<b>Impact: Likelihood to be Effective</b>	Programming has clearly defined goals and outcomes for target audience and processes in place to measure success. Intended program is strongly supported by appropriate research and by prior track record of success.

# 2025 Strategic Considerations

In addition to our review criteria, we will also take into account portfolio fit and areas for exploration which may include:

- **State-wide strategies** to support agency leaders in identifying what skillsets or experiences youth should gain through the education system, or expand access to career connected learning (CCL).
- Approaches that remove barriers for **employers** to participate in or offer CCL.
- Strategies or resources for **parents and guardians** in navigating school choices or supporting their youth in post-secondary planning.
- Innovations in professional development or resources to better prepare **educators** in implementing or integrating CCL in schools.
- Support for **public school districts, including charter school networks**, to scale up or pilot new CCL programs to new locations or populations.

# Reporting Requirements

- We work closely with each grant organization during the contract phase to establish reporting metrics and impact measures that are **mutually relevant**, aligning with both your organization's priorities and our strategic objectives.
- Organizations can expect to submit **at least one written annual report**, tailored to the size of the organization, the scope of the proposal, and the type of grant. These reports are straightforward and focus on the agreed-upon measures of success and impact, combining both qualitative insights and quantitative results.
- While some organizations may be asked to participate in additional check-ins, these are designed to be **informal and require minimal preparation**, making it easy to share progress.



# Grant Application Questions

## Systems Change

**\*\*Recommended word limit:** Up to 500 words per long form question

- Estimated annual #of individuals (ex. youth, parents/guardians, educators, employers, community members) directly served through ASA funding **and** across the organization.
  - If the work does not involve youth: Provide estimated # of youth indirectly served through ASA funding **and** across the organization.
- Please provide brief background information on your organization including:
  - mission
  - existing programs provided
  - time in operation
  - examples of prior success in projects of this kind
  - and your organization's capacity and experience in (1) driving system change efforts or (2) thought leadership campaigns, as applicable.
- What systems and areas of career connected learning are you looking to impact?
- What will your approach be to implementing the change you seek and what are the key outcomes for this project?
- Describe the strength of your current networks and partnerships that will support these efforts. Additionally, provide any specific opportunities for collaboration with ASA beyond funding.
- How will this proposal demonstrate a strong commitment to removing barriers for participation in CCL?
- What is your organization doing to elevate the voices of the youth served? Please provide specific examples.

## Direct Service

**\*\*Recommended word limit:** Up to 300 words per long form question

- Estimated annual #of individuals (ex. youth, parents/guardians, educators, employers, community members) directly served through ASA funding **and** across the organization.
  - If the work does not involve youth: Provide estimated # of youth indirectly served through ASA funding **and** across the organization.
- Please provide brief background information on your non-profit organization including:
  - mission
  - existing programs provided
  - time in operation
  - and examples of prior success with programs serving youth.
- For what career connected learning initiative are you seeking funding, and what makes this program unique, innovative or highly impactful?
- What will your approach be to implementing change and what are the key outcomes for this project?
- How will this proposal demonstrate a strong commitment to removing barriers for participation in CCL?
- Describe your sustainability and/or scalability plan for this initiative.
- What is your organization doing to elevate the voices of the youth served? Please provide specific examples.
- Please provide any specific opportunities for collaboration with ASA beyond funding.

## Research

**\*\*Recommended word limit:** Up to 300 words per long form question

- Please provide a brief background of your organization including:
  - mission
  - existing programs
  - time in operation
  - prior success with initiatives of this kind and your organization's capacity to conduct or manage the execution of large-scale research initiatives.
- What career connected learning (CCL) initiative, policy, system, or practice are you seeking to gain knowledge on, in order to advance the field? Provide specific research questions you anticipate studying.
- What are the desired outcomes of this research (including anticipated audience #s) and how do you plan to disseminate your findings to broader audiences? Include how you demonstrate a strong commitment to removing barriers for participation in CCL.
- Describe the strength of your current networks and partnerships that will support these efforts. Additionally, provide any specific opportunities for collaboration with ASA beyond funding.

### **Can we submit a single proposal that covers all three funding types?**

We encourage comprehensive proposals that address elements of all three funding types we offer. For reporting purposes, please select the primary funding type that best aligns with the proposal's outcomes or key deliverables.

### **Can I submit multiple proposals?**

Yes, you can submit multiple proposals for different funding categories, as long as each proposal is unique and focuses on distinct objectives.

### **What is the maximum amount of funding I can apply for?**

### **Do you provide support for general operating expenses?**

We aim to fund proposals with up to 20% of the requested amount allocated to operating costs.

### **What are the reporting requirements for funding?**

We will request annual updates on your reporting metrics. Additionally, ASA may conduct virtual informal check-ins to monitor progress and explore ways to further support your work.

### **What if we serve everyone and don't have a specific target population for our programs?**

If your program or initiative doesn't focus on a specific population, we recommend clarifying how you ensure equitable access to career-connected learning for all participants. For more details, please refer to Slide 3 under "Who We Serve."

### **Can I schedule a 1:1 meeting with ASA to discuss funding opportunities?**

To respect your time, we ask that you first submit an eligibility form at [asa.org/grant-funding-eligibility-form](https://asa.org/grant-funding-eligibility-form). If there is alignment, we will reach out directly to discuss a potential proposal or further conversations.

### **What if I'm a current ASA grantee? How can I apply for renewal?**

If you are a current ASA grantee, we will schedule a meeting after your final report to review your existing grant and discuss potential opportunities for continued collaboration.
